MINUTES OF TRANSFER COMMITTEE MEETING FOR AGT-2024 (Intra) IN RESPECT OF NON MEDICAL STAFF FROM MTS TO AD

In accordance with the Regional Office Memorandum No. 62.A/22/15/22/2022-Estt dated: 22.11.2023 & 10.01.2024, the transfer committee consisting of the undersigned members have met on multiple occassions for considering the tenure completion/request/compassionate transfer applications of all the Group C (Nonmedical) employees up to the cadre of SSOs (Intra Region) for the year 2024 and discussed the procedures to be adopted in accordance with the transfer policy issued by ESIC, HQ, New Delhi. The data is collected from online transfer module provided to the Chairperson of the committee as well as from SRO Visakhapatnam and Tirupathi.

It is found that there are certain discrepencies in the data provided online in the module with reference to the station/location/accouniting units/tenure of the employees and as such for these columns the information provided by RO/SROs has been treated as final. For all the other data Viz. options/compassionate application etc., the data provided in the transfer module is taken into account.

While processing the transfer requests, it has been observed that certain officals who have been ordered transfer/posting to New Branch offices in the AGT-2023 by RO/SROs as soon as they start functioning have not yet posted to thier ordered locations due to non opening of respective branch offices till date & have been continuing in the same station. Hence, the committee has now recommended transfer/postings of all such officials afresh taking their tenure into account.

The following General Principles have been adopted by the committee while recommending/ not recommending the transfers:

As per clause 7.4 of the Headquarters Transfer Policy, the officials posted at a station for longer period has been considered for transfer-out first from that station. As such, list is prepared as per the longest tenure and postings are recommended accordingly.

The committee observed that as per clause 7.2 of the transfer policy, all request for choice Postings will be considered subject to administrative feasibility and availability of vacancies.

Officials who have not given any option and have completed maximum tenure will be posted as per administrative feasibility. As per clause 7.6 of the Headquarters transfer policy, the oficials, due for retirement within two years may not be considered for transfer unless in administrative exigency. While recommending the transfers, efforts are made are made to have balanced staff position among all offices. Only requests received online up to the specified last date are being considered by the Committee. Presently, the committee has not considered the transfer applications of employees in the cadre of AD in view of their expected Inter Region Transfers by the ESIC, HQ office. Accordingly, the recommendations and reasons are recorded as below by the Transfer Committee in respect of Group C (Non-medical) employees up to the cadre of Social Security Officers based on their postings at present station, tenure completion at posted locations, administrative requirements, status on disciplinary grounds, posting in sensitive seats (as per CVC guidelines) etc.

Based on the principles and the criteria outlined above, the committee proposes the transfer/posting of the officials in the list attached.
