The Financial benefit allowed under MACP Scheme shall be final, no fixation shall 111-A-33/16/01/LabCadre/2022/Admin-II I/2087264/2025 accrue at the time of regular promotion i.e. posting against a functional post in the higher grade, only difference of pay

level/grade pay would be made available.

The aforesaid incumbent may exercise the option for fixation of pay as enumerated under FR 22(1)(a)(i) with one month from the date of issue of this order.

The Financial Up-gradation under MACP Scheme, shall, however, be subject to the terms and conditions enumerated under Govt. of India, DOPT, O.M. No. 35034/3/2008 –Estt. (D) dated 19-05-2009 and subsequent clarification/instructions 111-A-33/16/01/NO/MACP/2022Admn-II I/1665265/2024 issued in the matter from time to time.
