2. Reservation will be as per Government of India guidelines issued from time to time.
3. As per EWS guidelines posts are not carried forward, hence; in case of non-availability of EWS candidate; other category candidates may be allowed provisionally to apply for the post subject to the condition that they will be considered for the post as an UR candidates & the selection will be only on merit basis.
4. In case of non-availability of reserved category candidates in the advertised post, the vacancy may be filled up for less than 45 Days as de-reserved seats(s).
5. All Candidates must have up-dated Medical (NMC/ State Medical Council) with all post MBBS/ MD/ MS Qualification(s). - (a) Professor: Fixed Basic Pay of 1,23,100/- and other allowance as admissible.  
(b) Associate Professor: Fixed Basic Pay of Rs. 78,800/- and other allowance as admissible.  
(c) Assistant Professor: Fixed Basic Pay of Rs. 67,700/- and other allowance as admissible.
