- (i) Estimated cost of this bid is Rs. 120 Lakh.
- (ii) ESIC reserves the right to accept/ reject any bid and to cancel the bidding process at any time and reject all bids, at any time prior to placement of order, without thereby incurring any liability.

2. ELIGIBILITY CONDITIONS FOR TENDERER:

- (i) The tenderer must have a Registered Branch Office in Delhi with a functional telephone for round the clock for booking of the requirements.
- (ii) The bidder should be a well-established taxi agency/firm having a fleet of latest models of taxies/cars.
- (iii) The bidder should have at least Three years of experience of providing such services to Govt./PSUs/Autonomous Body (copy of Satisfactory Performance Certificates to be uploaded).
- (iv) The bidder must have successfully executed/completed similar over the last seven financial years previous to the current financial year: -
 - a. Three similar completed services with annualized value not less than the amount equal to 40% (forty percent) of the estimated annualized cost; or
 - b. Two similar completed services with annualized value not less than the amount equal to 50% (fifty percent) of the estimated annualized cost; or
 - c. One similar completed service with annualized value not less than the amount equal to 80% (eighty percent) of the estimated annualized cost.
- (v) The bidder should have not been blacklisted by any Central State Govt. agency in the past three years (Undertaking to be uploaded).
- (vi) The bidder should have Average Annual turnover of Rs.180 Lakh during Last Three Financial Years i.e. 2022-23, 2023-24, 2024-25 (CA Certificate/Balance sheet/Profit and Loss account to be uploaded).

3. TERMS & CONDITIONS:

- (i) This agreement will be effective for a period of two years and may be extended for one year on mutually agreed terms and conditions subject to satisfactory performance.
- (ii) The successful bidder shall have to submit a Bank Guarantee of Rs. 4,80,000/- with the validity beyond two months of the contract period which will be retained as security towards Contract Performance Guarantee (CPG) and no interest thereon shall be payable.
- (iii) Exemption for EMD shall be applicable to Micro and Small Enterprises as defined in MSE procurement policy issued by Department of Micro, Small and Medium Enterprises(MSME).
- (iv) The empaneled Agency has to provide Taxi at the desired location within Delhi on telephonic intimation from the authorized person of ESIC Hqrs. Office within 02 hours. The taxies may be requisitioned at any time of the day and night. Billing will start from the location of service.
- (v) It shall be the responsibility of the Service Provider to get meter reading of vehicle noted by the user, before proceeding on the trip and after completion of journey.
- (vi) Log Book should be maintained duly signed by the user of the vehicle on the same day/immediately after availing service. It will be the responsibility of the Service Provider to get the log book signed by the user on completion of the journey.
- (vii) In case of any delay/non-execution of the order beyond stipulated date & time, including any extension permitted in writing or verbally, a penalty Rs.300/- per complaint may be imposed. In case the taxi is not made available at the appointed time and desired location, the ESIC is at liberty to make arrangement at its cost and risk and

the charges may be deducted from pending bills or by invoking the Security Deposit or by raising claims.

- (viii) While performing the duty, if a vehicle is rendered out of order, Agency shall send the replacement within 60 minutes failing which ESIC shall be free to make alternate arrangement at the cost and risk of empaneled Agency
- (ix) In order to provide better service to ESIC, vehicles provided shall not be more than 5 years old at any point of time during the tenure of contract.
- (x) The Antecedents of the Drivers deployed should be properly verified and their details including Name, Address, Telephone No., Photograph, Copy of Driving License, Aadhaar Card, etc. must be kept in records.
- (xi) Vehicles provided should be fitted with neat, clean and well-maintained upholstery and accessories including Fire Extinguisher, GPS System and emergency SOS button.
- (xii) Parking and Toll Tax will be reimbursed by ESIC whenever incurred during the usage of vehicles by ESIC.
- (xiii) The Drivers of the Vehicles shall follow all the traffic rules and other regulations prescribed by the Govt. from time to time and ESIC will not be responsible for penalties imposed by authorities in case of any violation. The Drivers should be conversant with all the important places and roads in Delhi/NCR. All Drivers should wear proper uniform of preferably similar color & cloth.
- (xiv) All liabilities arising out of any legal dispute, accident, break down etc. shall be borne/paid by the Service Provider.
- (xv) No compromise will be made by ESIC Authority in matter of punctuality, cleanliness, obedience, promptness in behavior etc. on the part of the Drivers. If the service provider at any point of time during official duty fails to perform its duty as directed by the ESIC Authority, the Performance Security Deposit may be forfeited and the contract may be liable to be cancelled without further notice by the competent authority.
- (xvi) Penalty may be charged in case of default of any clause of this agreement.
- (xvii) Any misconduct/misbehavior on the part of Driver deployed by the Service provider may be attributable to the service provider with all the consequences appurtenant thereto and the concerned Driver should be replaced immediately by the Service Provider.

3. All vehicles should be fitted with neat, clean and well-maintained upholstery and accessories including Fire Extinguisher, GPS System and emergency SOS button.
4. Parking and Toll Tax will be reimbursed by ESIC whenever incurred during the usage of vehicle by ESIC.
5. The Drivers of the Vehicles should follow all the traffic rules and other regulations prescribed by the Govt. from time to time and ESIC will not be responsible for penalties imposed by authorities in case of any violation. The Drivers should be conversant with all the important places and road in Delhi/NCR.
6. All liabilities arising out of any legal dispute, accident, break down etc. shall be borne/paid by the firm.
7. No compromise will be made by ESIC Authority in matter of punctuality, cleanliness, obedience, promptness, behavior etc. on the part of the Drivers. 3. The ESIC reserves the right to terminate the contract at any time by giving one month written notice, on the ground of unsatisfactory services or breach of any of the terms of the contract, and reserves the right to forfeit the security retained towards performance guarantee.
